- Each RSU represents a contingent right to receive one ADS.
- These ADSs were sold automatically to cover taxes upon vesting of RSUs.
- The RSUs vest in equal annual installments over four years beginning on 06/25/2023, the first anniversary of the date of grant. Vested shares will be delivered in the form of ADSs to the reporting person following vesting.
