- This transaction represents the disposition of shares to cover taxes.
- Each Restricted Share Unit represents a contingent right to receive one American Depositary Share (ADS), which represents ten Ordinary Shares of the issuer.
- The Restricted Share Units vest in equal annual installments over five years beginning on 8/17/2021, the first anniversary of the date of grant. Vested shares will be delivered in the form of ADSs to the reporting person following vesting. Restricted Share Units were previously reported on Table I. Restricted Share Units are now being reported on Table II.
